









與香港整體人口比較,已接種三針的人士佔呈報個案的比例顯著較低,在住院危殆/嚴重及死亡個案中的佔比更是極低。這似乎反映接種三針能有效防感染、重症及死亡。

As compared to the Hong Kong overall population, those that have received 3 doses account for a much lower proportion among reported cases, and an extremely low proportion among the hospitalised critical/serious and deceased cases. This seems to suggest effectiveness of 3 doses in preventing infection, serious illness and fatality.
