These non-Hong Kong residents who are eligible to receive vaccination may not be included in the baseline population eligible to receive vaccination. Separately, the relevant baseline population is not based on real time figures and there may be deviations from the actual situation. Therefore, vaccination rate may be higher than 100%.









與香港整體人口比較,已接種三針的人士佔呈報及住院危殆/嚴重個案的比例顯著較低,在死亡個案中的佔比更是極低。這似乎反映接種三針能有效防重症及死亡。

As compared to the Hong Kong overall population, those that have received 3 doses account for a much lower proportion among reported and hospitalised critical/serious cases, and an extremely low proportion among deceased cases. This seems to suggest effectiveness of 3 doses in preventing serious illness and fatality.
