Separately, the relevant baseline population is not based on real time figures and there may be deviations from the actual situation. Therefore, vaccination rate may be higher than 100%.











與香港整體人口比較,已接種三針的人士佔呈報及住院危殆/嚴重個案的比例顯著較低,在死亡個案中的佔比更是極低。這似乎反映接種三針能有效防重症及死亡。

As compared to the Hong Kong overall population, those that have received 3 doses account for a much lower proportion among reported and hospitalised critical/serious cases, and an extremely low proportion among deceased cases. This seems to suggest effectiveness of 3 doses in preventing serious illness and fatality.


