









與香港整體人口比較,已接種三針的人士佔目前為危殆/嚴重住院個案的比例較低,在死亡個案中的佔比更是極低。這似乎反映接種三針能有效防重症及死亡。

As compared to the Hong Kong overall population, those that have received 3 doses account for a lower proportion among currently hospitalised cases with critical/serious condition, and an extremely low proportion among deceased cases. This seems to suggest effectiveness of 3 doses in preventing serious illness and fatality.
