Note 2: According to the latest requirement of the Guangdong Provincial Government, starting from 10am on August 7, save for persons who received prior approval by Guangdong for performing essential official and business duties and cross-boundary goods vehicle drivers who would continue to be subjected to the prevailing policies applicable to them, all other persons who are entering Guangdong would be required to present a valid proof of a negative COVID-19 nucleic acid test result issued by one of the testing institutions recognised by the HKSAR Government. The negative test result would be valid within 24 hours from issue time of the report.
註二：按廣東省政府的最新要求，自八月七日早上十時起，除經批准的公務商務豁免人員和跨境司機按現行規定執行外，其他人員入境廣東時，必須持有香港特區政府認可的醫療機構發出的 24 小時內有效核酸檢測陰性結果證明（由報告發出時間起計）。

Note 3: For persons who are exempted from the 14-day compulsory quarantine in Hong Kong under the "Compulsory Quarantine of Certain Persons Arriving to Hong Kong Regulation" (Cap. 599C of the Laws of Hong Kong) and are currently

in Guangdong Province, if they plan to re-enter Guangdong Province within a short period of time after returning to Hong Kong, they may visit testing institutions in Guangdong Province that are recognised by the Hong Kong SAR Government to conduct COVID-19 nucleic acid testing for inspection at mainland ports. Note 4: According to the latest requirement of the Macao Special Administrative Region Government, starting from 6am on August 7, all persons entering Macao would be required to present a valid proof of a negative COVID-19 nucleic acid test result issued by one of the testing institutions recognised by the HKSAR Government. The negative test result would be valid within 24 hours (e.g. for a nucleic acid test conducted on August 6, the negative result report can be used for entering Macao on August 7).
