Note 2: Members of the public must pay attention to and ensure that they can meet the new requirements (a valid proof of a negative COVID-19 nucleic acid test result within 24 hours and issued by one of the testing institutions recognised by the HKSAR Government) when travelling to Guangdong (GD) or Macao to avoid hiccups when crossing the border. When they re-enter Hong Kong after being refused of entry in the Mainland, they will be subjected to compulsory quarantine of 14 days pursuant to the Compulsory Quarantine of Certain Persons Arriving at Hong Kong Regulation (Cap. 599C). Members of the public should pay extra attention to avoid such a situation. Moreover, they should be aware of any compulsory quarantine requirements upon entry to GD or Macao.

Please refer to the relevant departments of the governments of the Guangdong Province or Macao SAR for the latest quarantine arrangement or quarantine exemption details. Contact details are as follows:

Note 3: For persons who are exempted from the 14-day compulsory quarantine in Hong Kong under the "Compulsory Quarantine of Certain Persons Arriving to Hong Kong Regulation" (Cap. 599C of the Laws of Hong Kong) and are currently in Guangdong Province, if they plan to re-enter Guangdong Province within a short period of time after returning to Hong Kong, they may visit testing institutions in Guangdong Province that are recognised by the Hong Kong SAR Government to conduct COVID-19 nucleic acid testing for inspection at mainland ports.
